Sunday, May 31 at 4 p.m. — Summerhill Campus East Parking Lot

A Church Conference will be held to vote on the following item on the ballot:

• As a member of New Covenant United Methodist Church, I vote to approve the launch of the Lake Deaton campus as a separate United Methodist Church effective July 1, 2020. (Circle one) YES NO

A vote in favor of the ballot item will authorize and direct the Board of Trustees of New Covenant United Methodist Church to transfer to the new Lake Deaton church control of the real property holding company that is the borrower of the construction loan for the Lake Deaton campus from The Florida United Methodist Foundation and all the right, title, and interest of New Covenant United Methodist in all the land, buildings, and property constituting the Lake Deaton campus and all service contracts relating to the Lake Deaton campus.

Following the Church Conference, if the launch is approved, those who intend to become members of the Lake Deaton Church will remain for a Constituting Conference of the new church at which the following will take place:

- They will be welcomed into membership of the new church by transfer of membership.
- They will approve the name of the new church.
- They will elect the members of the Church Council (Strategic Action Leadership Team) for the
- The District Superintendent will declare the new church to be properly constituted.

Immediately following the Constituting Conference, the District Superintendent shall conduct a Charge Conference of the new church for the following purposes:

- · Organizing the new church, including the election of its officers, committees, and committee
- Authorizing the assumption by the new church of control of the real property holding company that is the borrower of the construction loan for the Lake Deaton campus and the guaranty of that loan
- Authorizing the modification of the construction loan for the Lake Deaton campus to provide for interest only payments for two years or any longer or shorter period of time approved by The Florida United Methodist Foundation
- Authorizing the assumption by the new church of the liabilities, obligations, and indebtedness of New Covenant United Methodist Church under the service contracts relating to the Lake Deaton campus that become due and payable or required to be performed after the date of transfer to the new church

As a reminder, only Full Members who are present are permitted to vote. Associate and Affiliate Members may not vote, but may certainly attend. If you would like to confirm your membership status or discuss changing it, please contact Barb Prindle at bprindle@ncumcfl.com or (352) 750-4529 by Thursday, May 28.

If the Church Conference vote is favorable, the intent will be to launch July 1. If not, there will be a reevaluation by the leadership team.



You will be asked to pull up where a staff member/volunteer will greet you. Members will be checked in, and provided a packet that will include instructions and the ballot. All vehicles will proceed to the East Parking Lot and be directed by volunteers where to park. Please comply with the volunteers' directions. All vehicles will face North (towards the Columbarium) and the stage will have a PA system. We will also have a radio transmitter for autos and carts; directions will be provided in packets at registration. Please note that no one may leave his/her golf cart or automobile.

Once the vote is taken and finalized, if it's positive, then Lake Deaton members will remain to vote on specific items related to the launch.

When I discuss or refer to these weekly writings, I call them my TTTs (Time, Talents & Treasures). Today I want to thank you for your continued giving to your church and tell you about the PPP (Payroll Protection Program). You heard about it on the news. It was the first time that churches were allowed to apply for an SBA (Small Business Association) loan.

In Mid-March our donations had dropped 49 percent and the church leadership did not want to terminate or layoff any of our staff, so we applied for a loan. Citizens Bank and the SBA approved a \$400,000 loan for our church.

As a result of the loan, and thanks to you, our congregants, increasing your giving, we have paid the staff throughout the pandemic and they will continue to be paid.

Thank you again for your outstanding support of your church and your staff. We love THEM all.
